- c. Descriptions of Plot/Flat/House in any City/Town.
- d. Descriptions of Mill/Factory/Enterprise/Business owned by your father/mother/any member of your family any where.
- e. Total land owned by Parents and evidence of land tax/Municipal Tax/ other taxes paid.
- f. Monthly Income Certificate signed by the employer (for service personnel) and for other persons by Union Parishad Chairman, /Ward Commissioner.
- g. Evidence of the amount paid as rent per month if lived in hired house.
